### **Overview**

The High-Risk Neonatal course is a two-day course that covers the Tennessee Perinatal Educational guidelines, and discusses the diseases seen in the NICU along with the pathophysiology and care associated with those diseases for neonatal health care professionals. This course is designed for nurses and respiratory therapists taking care of babies in Level II and Level III NICUs. At the conclusion of the activity, learners will integrate into clinical practice at least one strategy or technique to provide stabilization and ongoing care to at-risk infants in the unit.
